The Trustees and Settlers above named desirous of creating a Trust for educational purposes and charitable activities to be undertaken by the Trust which is named as "SREE VIJAYANANDA GURUDEVA SMARAKA CHARITABLE TRUST."

The income of the Trust will be used for the payment of Salary, publication, Training educational and other developmental and charitable activities of the SREE VIJAYANANDA GURUDEVA SMARAKA CHARITABLE TRUST.'

Name of the trust and the founder

The name of the Trust shall be "SREE VIJAYANANDA GURUDEVA SMARAKA CHARITABLE TRUST'. The founder of this trust is Mathaji Guru Poornimamayi

Registered office and Area of operation

Registered office of the Trust is Narayani Madom, Vijayananda Ashram, Nalkalickal P.O. Aranmula., Kozhencherry Taluk, Pathanamthitta District, Kerala State and it activities will extend the whole state of Kerala.

Aims and objects

- (a) To establish, develop, maintain and run educational institutions, and the name of the school shall be Sreevijayananda Vidyapeedom, which exist absolutely for educational and charitable purpose and not for any profit.
- (b) To offer better education and culture to the students who shall be admitted in the school. In academic matters the Trust follows the directions decisions and syllabus of Bharatiya Vidhyanikethen, Kerala which is affiliated to Vidhya Bharathi.
- (c) To run and establish primary, upper primary, secondary and Higher Secondary Educational Institutions subject to the approval of the State and Central Governments and other authorities and to establish and run charitable institutions viz Hospitals, Nursing Homes, Nursing Schools infant houses orphanages.
- (d) To offer financial aid to any of the similar institution which are run by other charitable Trust or institution.
- (e) To award scholarship and financial assistance to the deserving students for their education.
- (f) To run pre-primary and primary education to all who wish to join the institution irrespective of class, caste, religion etc.
- (g) To conduct Medical camps and to render free medical aid to sick and poor people.

- (h) To publish magazines, books etc.
- (i) Affiliation or acquisition of the similar institutions to the trust for the above purposes.
- (j) Holding of properties and other assets for the trust.
- (k) Doing all other such lawful things that are incidental or conducive to the attainment of the above objects.
- (l) To same any other educational institution including colleges.
- (m) To keep the memory of Sree Vijayananda Gurudeve and to propagate his ideals
- (n) To promote Sanskrit Education, Sanskrit Schools and Job Oriented Education

Properties of the Trust

The Trustee and Settlers of the SREE VIJAYANANDA GURUDEVA SMARAKA CHARITABLE TRUST, hereby declare that a sum of Rs. 1,400/- (Rupees one thousand and four hundred only) has been set apart by her to the trustees for the purpose and objectives stated above.

The trust fund may be augmented by receiving further donations or by selling apart of the income of the Trust which will be decided by the trustees, such amounts are considered by them to be appropriated in order to further one or another of the object of the trust.

Constitution of the Trust

The following person hereby agree to be the first trustees of the trust and will constitute the first Board of Trustees.

There shall be a board of trustees consisting of 7 members including the Managing Trustee. Out of one shall be the Managing Trustee. 3 members shall be nominated by the Managing Trustee from among the members of the trust. 3 members shall be elected from the members of the Trust.

The Trustees shall hold office in their respective lives. Any vacancy arising in the office of the Trustee or Managing Trustees by reason of death, resignation or other valid reasons be filled in by the surviving or remaining Trustees.

Membership

1. Persons joining the deed of Trust initially for its registration.
2. Those who are subsequently nominated by the Managing Trustee during his/her life time and afterwards by the unanimous decision of the trustees.
3. The members of the trust shall have the age of above 18 years and of good character.

Managing Trustee

The founder Mathaji Guru Poornimamayi shall be the Managing Trustee of the Trust for her life time.

- (a) The Managing Trustee shall nominate the successor from among the trustees who shall be the Managing Trustee.
- (b) In the absence of such nomination the board of trustees shall elect a Managing Trustee from among themselves.
- (c) To purchase, taken on lease and erect, maintain, keep construct and put up buildings equipments, lands etc., and to dispose of the same.

Joint Managing Trustee

There shall be a joint Managing Trustee who shall be elected from the board of Trustees.

Capital fund of the Trustee.

The authors of the trustee hereby place in trust a sum of Rs.200/- each for the above mentioned charitable and educational purpose. The trust fund may be augmented by receiving further donations or by selling apart of the income of the trust as will be decided by the trustees, such amounts such are considered by the to the appropriated in order to further one or another of the object f the trust.

The powers and Privileges of the Trustees

- (a) To receive and keep all trust funds and money by way of gifts, donations, contributions and grants and other assets of the Trust.
- (b) To open and close accounts with any bank or banks in the name of the Trust and shall operate upon such accounts.
- (c) To raise or receive all such loans and advances as they may think proper for the conduct of the Trust.
- (d) To appoint individuals and group of persons to take care of the Management of the Trust property or properties on the case may be.

Powers of the Management Trustee

To have control over assets of the Trust and to execute become party to sing, acknowledge and register all deeds, agreements and writing and to give effectual discharge on behalf of the trust.

- (a) To draw, make accept endorse, discount, negotiate, execute check bills of exchange and other negotiable instruments.
- (b) To institute, conduct, compound, withdraw or compromise, adjust, refer to arbitration or abandon any legal or other proceedings, claim or disputes by or against its officers or employees concerning the affairs of the Trust and to sign and to verify vakkalaths, complaints, statements, Affidavits and other proceedings before all courts of law and other Government authorities both Central and state.
- (c) To appoint from time to time and at any time to suspend, dismiss, remove or discharge any person under his control including Clerks, Accountants and other employees with such powers and such duties and upon such terms duration of office, remuneration or otherwise as the Board of Trustees shall think proper.
- (d) To do such other acts or deeds consistent with powers concerned have in and such other acts authorized by the Board of Trustees by a resolution. The Managing Trustee can delegate such work or works to other trustee which are to be done by him.
- (e) The managing trustee has every right to nominate members of the trust.
- (f) To avail loan or any other financial assistance from any bank or any other financial institutions.
- (g) To appoint teachers, staffs or other employees to conduct the school and other institutions which are conducted by the trust.

Proceedings of the Trust

- (a) The Board of Trustees shall meet at least once in every month, often if necessary on the requisition of the Trustees. The quorum for the meeting shall be five.
- (b) The chairman of the Trustees shall be Managing Trustee or any other Trustee mutually agreed upon.
- (c) The vote for majority present at the meeting shall prevail and in case of equal division the Chairman of the meeting shall have a casting vote.
- (d) No act or resolution of the Board shall be invalid merely by reason of there being one or more vacancies in the board of Trustees.
- (e) The Board of Trustees shall also be competent to pass any resolution by circulation among them.

Secretary

There shall be a secretary of the trust who is appointed by the Managing Trustee who shall maintain the records and accounts of the trust and convene the meeting of the trust. He is to work under the directions of the Managing Trustee.

Treasurer

There shall be a treasurer appointed by the Managing Trustee who shall operate Bank Accounts jointly with the Managing Trustee.

Secretary shall be ex-officio member of the trustee.

- (a) Bank accounts and finance shall be in the name of Managing Trustee and Treasurer who shall operated the same
- (b) General Body of the trust shall meet at least once in a year Quorum of the General Body meeting shall be 1/3 of the total member of trustees.
- (c) Amendments to the Bye-laws of the trust shall be made by the General Body of the trust by 2/3 majority of the members present.
- (d) The accounting year of the Trust shall be Financial year. At the end of every financial year the accounts shall be presented in the Board of Trustee and after its approval it shall be presented and approved by the General Body.
- (e) Necessary sub rule shall be made by the Board of Trustees for the administration of the trust.
- (f) In the case of termination or dissolution of the Trust the properties and assets of the trust shall stand transferred to Thirthpada Parampara Ashram Trust, if not possible to any other public charitable institution having similar objets or resolved by the General Body meeting of the Trust.
- (g) Any amendment, alternation to the trust deed shall be with the prior approval of the commissioner of income tax.
- (h) The Board of Trustees shall act as a man of ordinary prudence with care and interest in discharging duties dedicatedly and faithfully for the greatest advantage to achieve the objectives of the Trust.
- (i) The Board of Trustee should not act in deterioration of the name and assets of the Trust. If any loss occurs because of the dishonest and carelessness of a Trustee then he/she should be personally liable for such loss or losses.
- (j) If a Trustee is proved by appropriate evidence of dishonesty and his activities are against the interest of the Trust then the remaining Trustees may server notice of termination on him after calling for his/her explanation.
- (k) If any difference of opinion arising between the Trustees or if any problem arise to the beneficiaries in getting the benefit from the Trust them the Trustees can approach the court for an arbitration.
- (l) The board of Trustees shall be entitled to make and prescribe from time to time Rules and bye-laws, Regulations for carrying of the objectives of the Trust and also meeting or amend such bye-laws, Rules and Regulations within the frame work of the trust.
- (m) The secretary shall give at least 3 days notice for the executive committee and 7 days notice for the General Body meeting.

(m) Managing Trustee shall preside over all proceedings of the trust and its committees.

(n) Amendments to the constitutions of the trust shall be made in General Body meeting of the Trust with 2/3 majority out of the total number of member and specially convened for the purpose.
